


#### INVESTMENT OBJECTIVE

The Simplici BCI Income Plus Fund is an enhanced income portfolio with the primary objective to achieve a high level of sustainable income and stability of capital invested.

#### INVESTMENT POLICY

The Simplici BCI Income Plus Fund is an enhanced income portfolio with the primary objective to achieve a high level of sustainable income and stability of capital invested. The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act, subject to a maximum equity of 10% of the portfolio's net asset value. Investments to be acquired for the portfolio may include equity securities, property securities, property related securities, interest bearing securities, non-equity securities, notes, money market instruments, preference shares and assets in liquid form. The portfolio may invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.


